- 1) Data Entry Operator(s) (DEOs) working in different Bangla Sahayata Kendra(s) (BSKs) across the state will be allowed to enhance the remuneration of Rs.16,000/- per month w.e.f 01.10.2024 and
- 2) They will be entitled 3% yearly enhancement w.e.f 1st July every year to commence from 2025 onwards.
