### NOTIFICATION

In order to provide security of tenure, appropriate emoluments and certain terminal benefits subject to fulfilment of the conditions as laid down vide no. 124-Estt. /e-Gov./WBSRDA/01/2020 dated 08.07.2020, no. 515-PAR-23012/10/2020 e-Gov. dated 27.10.2021 and the terms issued time to time, the Data Entry Operators (DEOs) as are engaged in Bangla Sahayata Kendras (BSKs) set up across the State vide no. 185-P&AR/IT-03/2017 dated 12.10.2020 read with no. 352-CS/ 2020 dt. 14.10.2020, the benefits as mentioned in paragraph 2 of the no. 192-IT/06/2020/P&AR-e-Gov. dated 16.10.2020 are extended *mutatis mutandis* to them.

2. The authority for sanctioning benefits to the Data Entry Operators (BSKs) under para 2.2 of no. 192-IT/06/2020/P&AR-e-Gov. dated 16.10.2020 is hereby accorded to the authorities as mentioned vide no. 887/CS(L) dated 13.10.2020 of respective jurisdiction. However, for benefits under para 2.3 and 2.4 of the aforesaid notification, the Data Entry Operators (BSKs) shall apply to the P& AR Department being the nodal department with recommendation of the authorities as mentioned vide no. 887/CS(L) dated 13.10.2020.

3. **No Data Entry Operators (BSKs) engaged against the Bangla Sahayata Kendras can be replaced / transferred without prior concurrence of the P&AR Deptt.,** being the nodal department. However, by giving one month notice and with concurrence of the P& AR Deptt., the District Coordinators / Coordinators in Municipal Commissionerate as mentioned vide no. 887/CS (L) dated 13.10.2020 of respective jurisdiction **can terminate the DEOs for violation of any terms engagement.** Similarly, the DEOs can resign by giving one month notice to the District Coordinators / Coordinators in Municipal Commissionerate who shall forward it to the P&AR Deptt. for acceptance.

This order will take immediate effect.
